I agree to park my vehicle in the designated vendor parking lot and be set up by 10:00 am. Break down to begin no earlier than 3:00 pm. VEHICLES ARE NOT ALLOWED IN THE COURTYARD UNTIL AFTER 3PM.

I agree to allow pictures taken of me at the special event to be used to promote the event in the future.

I agree to abide by the “no smoking or dogs within 20’ of food” rule.

I agree to be responsible for making sure that my business is compliant with all rules and regulations required by the city and state as they pertain to operating my business, and to give the event coordinator copies of all required insurance, permits, licenses, etc.

I agree to have a trash container for public use in my space and to dispose of any garbage at the end of the evening in containers designated by the event coordinator.

I agree to display a sign identifying my name or the name of my business and the city or town where my production occurs.

I agree to wear “shirt and shoes” while in my space.

I agree that there will be no cancellations due to rain or other inclement weather.

I agree that I will receive **no refunds for cancelling**, and that any paid funds will be considered a donation to the Rotary Club of Sonoma Mountain Twilight.

I agree to abide by any instructions given to me by event coordinator.
